#### **D-11** Update

Operationally, District Eleven has had a notable quarter executing 258 search and rescue cases, interdicting more than 12,604kgs of cocaine, 5,595 pounds of marijuana, and responding to the tragic vessel fire on the Diving Vessel CONCEP-TION during Labor Day. District Eleven is continuing to play a significant role in the investigation of the incident, along with the FBI and the National Transportation Safety Board. Our vessel inspection specialists surged forward following the incident to conduct inspections of all overnight commercial passenger vessels to ensure that the boat operators were following all requirements and all vessels were in standard with regulations. This was a major task as District Eleven has the largest number of these type of vessels in the country. District Eleven has also played a significant role in supporting the migrant crisis on the Southwest Border and many of the unit's reservists and active duty members have been rotating through various border stations for month-long deployments. As the crisis has been winding down we are anticipating having all of our members back home from supporting this mission with their families for the holidays.

The people of District Eleven continually impress with their dedication and devotion to duty and community. We recently hosted visits from the San Francisco 49ers and the Second Lady of the United States. Mrs. Pence spoke at a spouses event to thank Coast Guard spouses and families for their support of their active duty members, especially during the challenging government shutdown. Spouses traveled from all over the Bay Area, from Monterey to Bodega Bay, to hear Mrs. Pence speak and to visit with one another on Coast Guard Island.





On the operational side, Rear Admiral Gautier recently awarded two Air Medals and other awards to members from Air Station San Francisco for a challenging Search and Rescue case near Santa Cruz and their outstanding response to Hurricane Harvey.

The District Eleven Command has continued a busy schedule of engagements around the District area of responsibility, across the country and in the Western Hemisphere, having completed trips to Peru, Costa Rica, the Department of Defense's SOUTHCOM Component Commanders' Conference and Joint Task Force - West this quarter. November concluded California's season of Fleet Weeks during which we worked with our fellow sea service members in Los Angeles, San Francisco and San Diego to conduct Defense Support for Civil Authorities exercises and engage across the maritime communities in these vital west coast ports. We have been continuing our engagement efforts with innovative companies through visits to General Dynamics in San Diego, the soon to be commissioned Blue Tech Center of Expertise at Scripps Institute of Oceanography, and In-Q-Tel, the CIA's non-for-profit investment firm. Of note, we greatly appreciated the Navy League's\* support during the ten year memorial to remember the fallen crews of Coast Guard C-130 Aircraft, RESCUE 1705, and Marine Corps Cobra helicopter, VENGEANCE 38. Your support helped us host an event that was widely attended by the C-130 crew's families. As fall winds down, we are gearing up for a busy holiday season and the start of what promises to be another dynamic year in District Eleven.


